WHAT DOES CORNERSTONE WEALTH STRATEGIES DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect, and share depend on the product or service you have with us. This information can include:

- Information we receive from you on account applications like Social Security Number, address, email address, date of birth, financial goals, assets, and income
- Account balances and transaction history
- Assets and investment experience
- Tax information
- Personal background

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Cornerstone Wealth Strategies chooses to share; and whether you can limit this sharing.

| How does Cornerstone Wealth Strategies protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We restrict access to nonpublic personal information about you to those individuals who need to know that information to provide products or services to you. |

| Why can't I limit all sharing? | Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. |
| What happens when I limit sharing for an account I hold jointly with someone else? | Your choices will apply to everyone on your account. |
| Definitions | |
| Affiliates | Companies related by common ownership or control. They can be financial and nonfinancial companies. Cornerstone has no affiliates. |
| Nonaffiliates | Companies not related by common ownership or control. They can be financial and nonfinancial companies. Customer's other professional advisors (e.g. attorney, accountant, insurance agent, broker-dealer, account custodian, etc.) with customer's written consent |
| Joint marketing | A formal agreement between nonaffiliated financial companies that together market financial products or services to you. |

Additionally, Cornerstone Wealth Strategies does not share information for affiliates' marketing purposes and do not share information about your creditworthiness with our affiliates.
